

The meeting of the Internal Complaint Committee was held on 21.09.2022 at 12.00 noon at Conference Hall, Dental College, Amravati.

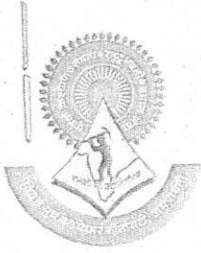
